7. What suggestions do you have for improving the MRL WG Industry Workshop?

- A little more time in workshop and less time with speakers and introductions. Add a training opportunity within it.
- Make it 1 & a half days instead of 1 day.
- More time to work through the team taskings and prepare responses
- We might need more time for subgroups during the event
- It might be helpful to identify what the break-out groups will be prior to the meeting and allow choices to be made. This would enable better preparation as well as assuring that there is a minimum participation in each group.
- An extra half-day or so would be great. Some valuable topics came up in the breakout sessions that we didn't have time explore ahead of preparing our outbrief.
- Something like an "Industry User's Forum" would be helpful. Maybe an open mic to discuss what works well with MRLs in industry, what problems are encountered, and how they are resolved (or not) internally. Or several presenters with 2-3 slides each. I think it would generate some great discussion and help to make the MRL construct more robust.
- Lots of work left to do after workshop suggested that we should have had a 2 or 3 day workshop instead
